## **U. S. DEPARTMENT OF AGRICULTURE**

### **Natural Resources Conservation Service**

**(NRCS):** NRCS employees work in every county in Indiana, hand-in-hand with land users to conserve natural resources on private lands. NRCS is committed to providing high quality technical assistance, conservation planning and program information support to private land users. **Farm Service Agency (FSA):** FSA administers a 'set-aside' program called the Conservation Reserve Program (CRP) to protect environmentally sensitive cropland, disaster programs, and guaranteed farm ownership (FO) and operating loans (OL) to eligible family-size farmers that can be used to purchase land, livestock, equipment, feed seed, and supplies. **Rural Development (RD):** RD offers technical and financial assistance and information to help agricultural producers and cooperatives get started

## STATE LEVEL ASSISTANCE

---

### **Purdue Cooperative Extension Service**

**(CES):** The Cooperative Extension Service is one of the nation's largest providers of scientific research-based information and education. Purdue Extension is a service tailored to meet the needs of Indiana. CES educators, specialists, and volunteers live and work in all 92 Indiana counties. ### **Indiana State Department of Agriculture**

### **Indiana Department of Environmental Management (IDEM)**

IDEM provides environmental oversight and technical assistance in communities and around the state. The agency provides information to businesses, educators, citizens, and farmers about environmental quality. ### **Indiana State Board of Animal Health**

**(BOAH):** The BOAH mission is to enhance Indiana's economy by protecting Hoosiers' investment in animal agriculture, wildlife, horses and companion animals; and to maintain a vital link in a safe food supply through the state meat and poultry and dairy inspection programs. **Indiana State Health Department:** Food Protection is the regulatory division responsible for inspections of food establishments on state property, manufacturing plants, processors, warehouses, packagers, and transporters of food products for distribution to another entity for resale or redistribution. They provide training and technical assistance to local health departments, consumers and businesses. ### **Office of Community and Rural Affairs**

## COUNTY LEVEL ASSISTANCE

---

### **Soil and Water Conservation Districts**

**(SWCD):** Across Indiana, 92 SWCDs—one in every county—help Indiana residents to conserve land, water, forests, wildlife and related natural resources that encompass our state's 23 million acres. All share a single mission: to coordinate assistance from available sources—public and private, local, state and federal—in an effort to develop locally driven solutions to natural resource concerns. **County Health Departments:** Each county in Indiana maintains its own office. County health departments fall under the regulations of the State Health Department, but may also enforce stricter regulations for an individual county. Contact the local county health department for specific food handling, processing, retail regulations, along with local animal ordinances.

## NON GOVERNMENT ORGANIZATIONS AND SERVICES

---

**Certifiers:** The USDA, Agricultural Marketing Service, National Organic Program (NOP) accredits private businesses, organizations, and state agencies to certify producers and handlers of agricultural products according to the NOP regulations. Visit the [www.usda.gov](http://www.usda.gov)

**Farm Bureau (FB):** The Indiana Farm Bureau is an advocate for farmers and through its policies and programs, promotes agriculture and improves the economic and social welfare of its member families. Banking services include mortgage loans and refinancing including loans for land, small farms and businesses. [www.infarmbureau.org](http://www.infarmbureau.org)

**Grower Groups:** Nearly every crop (pumpkin, vegetables, fruit, nuts, corn) and type of livestock (sheep, cattle, alpaca, llama) has its own grower group. The group may be local in scope, or part of a regional or national organization. These groups connect new growers and experienced growers, marketing opportunities, education, mentorship, and support. **Resource Conservation and Development (RC&Ds):** Regional RC&D Councils accelerate the conservation, development and utilization of natural resources and improve the level of economic activity and standard of living. RC&Ds work uniquely with public and private partnerships to build relationships carry out projects that meet locally identified resource needs.
